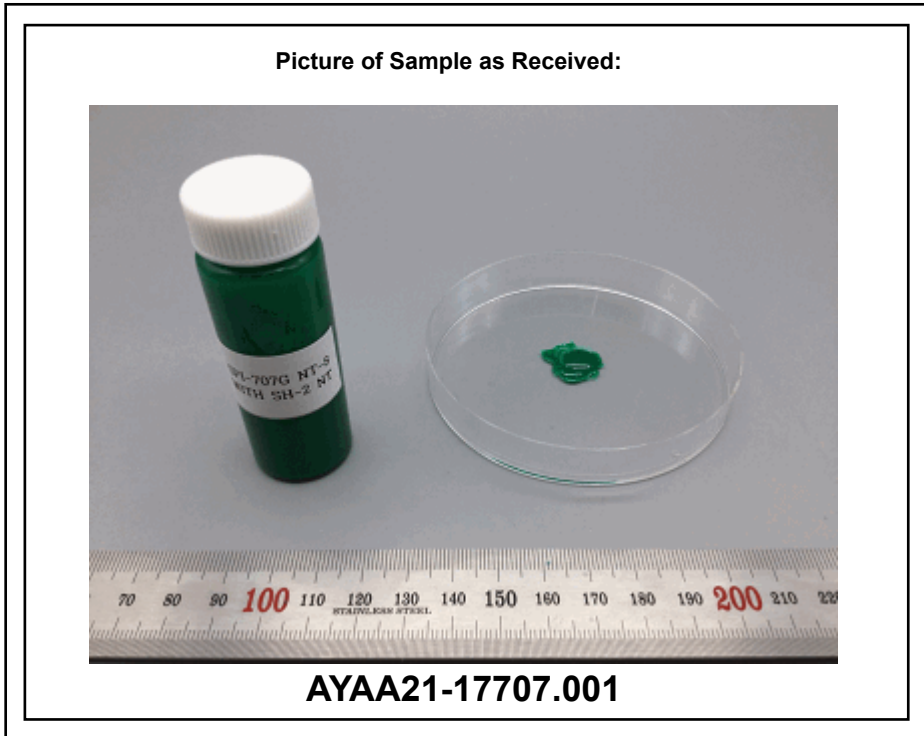

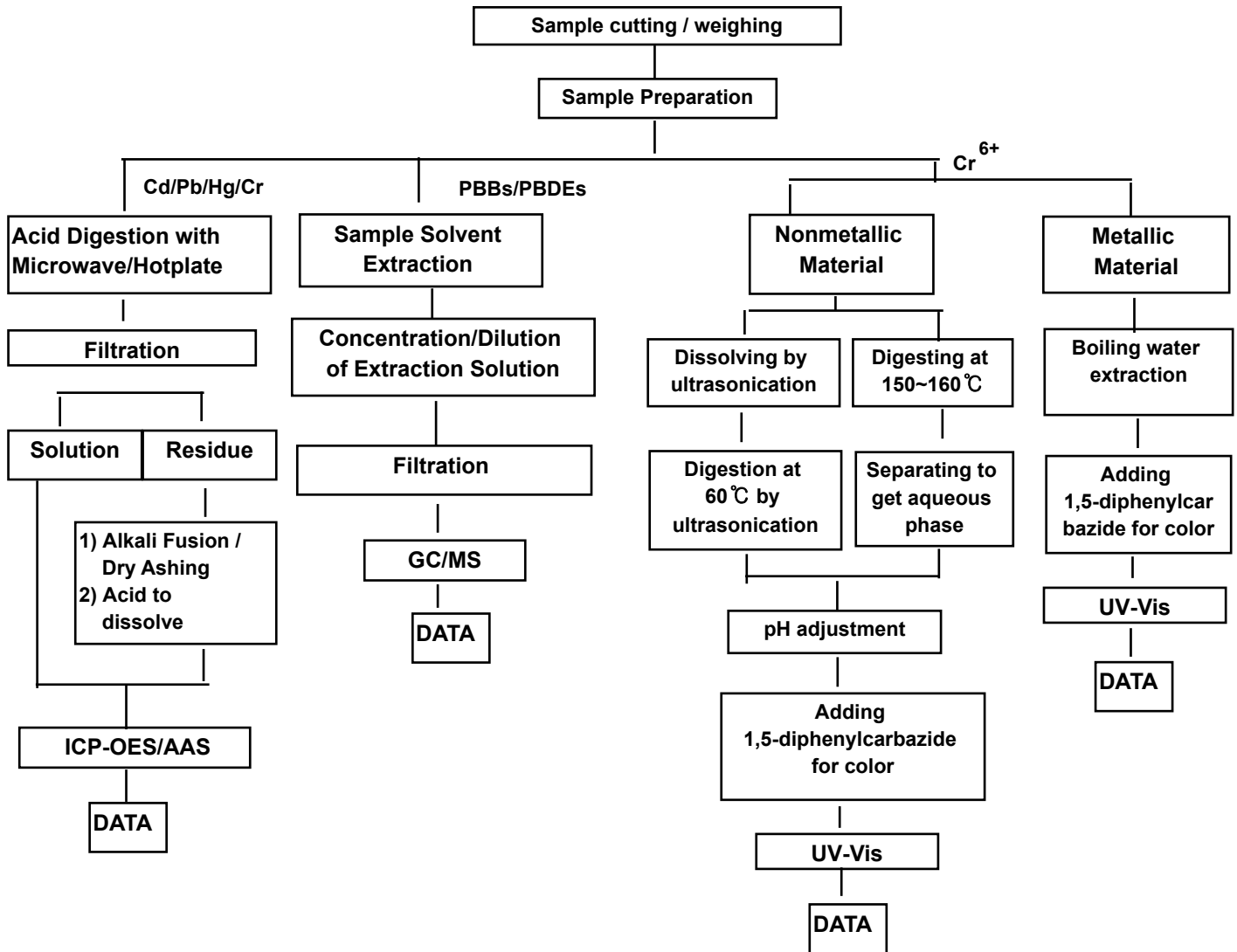

Testing Flow Chart for RoHS: Cd/Pb/Hg/Cr<sup>6+</sup> /PBBs&PBDEs Testing



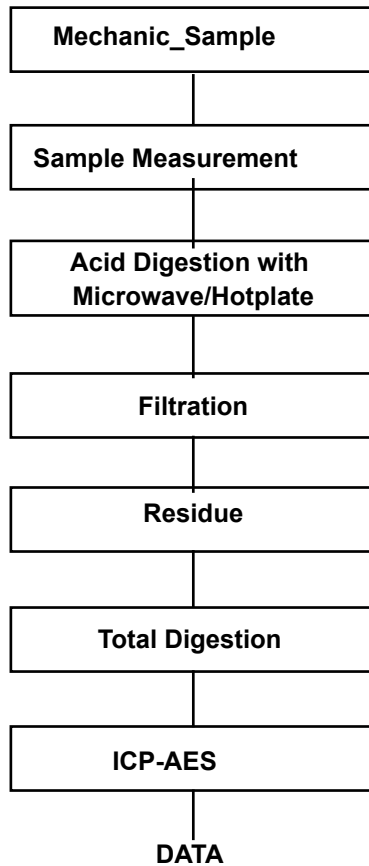

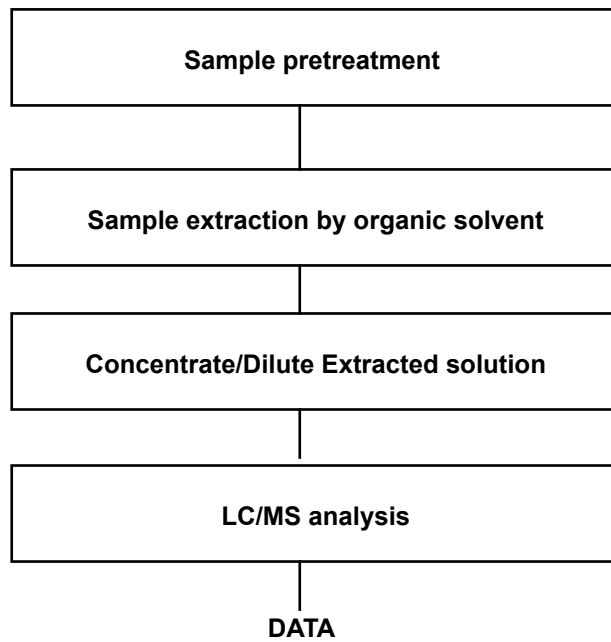

### Testing Flow Chart for HBCD

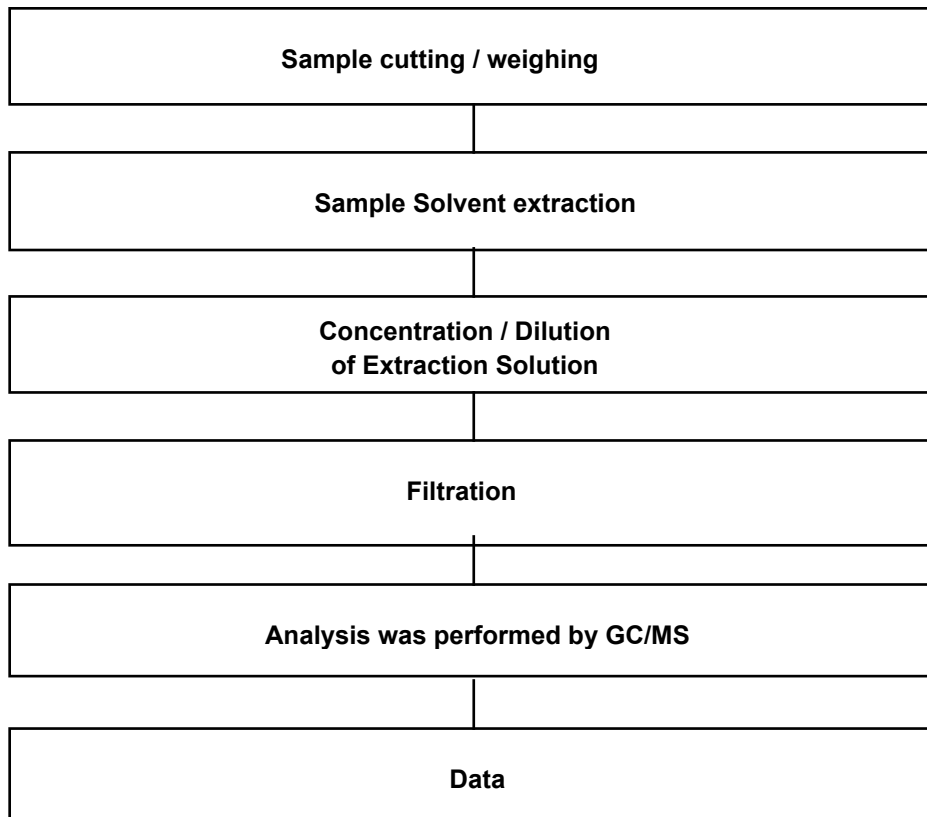
